TABLE TOP exhibits are best, but larger exhibits may be accommodated if necessary. The Exhibitor Fee covers:

- one (1) person;
- one (1) skirted table and two (2) chairs;
- 120 V - 20 AMP electrical service (only if requested at registration)
- admittance to all sessions, breaks, receptions and meals, and the trade show (Additional person needs to register as regular attendee)

Booth assignments will be made on a first-come, first-served basis, as registrations with payment are received. Booths will be assigned on-site via a sign with the organization's name placed on each exhibitor table.
